Dear Sir/ Ma'am,

Pursuant to Regulation 30 read with clause 20 of Para A Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and in continuation to our earlier disclosure dated June 28, 2025, this is to inform you that **Shubhshree Biofuels Energy Limited** (Formerly known as Shubhshree Biofuels Energy Private Limited and Shubhshree Bricks Private Limited) ("the Company") has received a communication dated **September 17, 2025** from National Stock Exchange of India Limited ("NSE") regarding the decision on application filed by the Company for waiver of fines levied for noncompliance with Regulation 33 of the Listing Regulations for the half year and Financial year ended March 31, 2025.

The Company had, vide its letter dated July 10, 2025, submitted a waiver application in accordance with the Policy on Processing of Waiver Applications issued by NSE. After considering the Company's representation, NSE has passed order for a **partial waiver** of the fine levied. The summary of the fine levied and waiver granted is as follows:
