d. Monitoring & reporting mechanism for projects

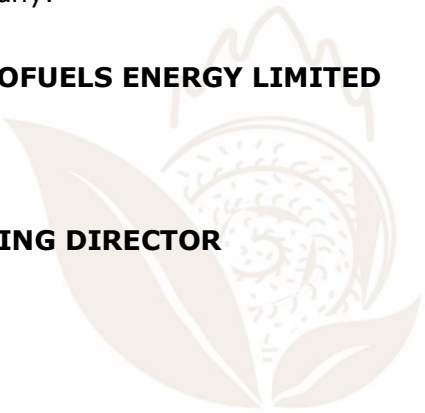
- The Company will continue to monitor project implementation and performance of the implementing agency/(ies)/vendor on periodic basis via field visits or review calls, as the case maybe.
